## CAPIC/MHSA Psychology Intern Stipend Program

### Ψ Qualified Sites Ψ

In order for a site to qualify for MHSA stipend purposes, the site must be funded in whole or in part by COUNTY MENTAL HEALTH dollars. If any part of an agency at that site receives some county MH funding, then the agency qualifies for MHSA stipend purposes. For this reason, large institutions (e.g. schools, hospitals) are often good candidates. This is often referred to the “one drop” rule, because one drop of county MH funding qualifies a site for MHSA stipend purposes.

Unfortunately, funding changes continuously and there is not a comprehensive list of qualifying sites for this CAPIC/MHSA stipend program. Below are some guidelines to assist you.

#### QUALIFYING SITES

- Any California county Behavioral/Mental Health Department.
- Any site run by a California county Behavioral/Mental Health Department.
- Any site that has a contract with a California county Behavioral/Mental Health Dept.
  - The county funds must come from the Behavioral/Mental Health Department, not simply from the county.
- A site receiving Short-Doyle 'SPECIALTY MENTAL HEALTH' funding (a type of matching Medi-Cal funding) if (a) only used for non-drug treatment diagnoses AND (b) the county DMH has a contract to pay for these services.

#### NON-QUALIFYING SITES

- Sites which receive no county MH funding (e.g. Kaiser Permanente).
- Sites run by the CA Department of Corrections & Rehabilitation (CDCR), regardless whether they also receive DMH funds. However, if a CDCR site has integrated MH services (e.g. where MH and CDCR work together) AND these services are run by MH, then those sites may qualify for our purposes. Orange County Youth Reporting Center (YRC) is one such qualifying site, but every county is different (of course).
- Sites which are only funded by the following, which are NOT qualifying funds for the MHSA stipend program:
  - Prop 63 funds (Mental Health Services Act of 2004 aka MHSA)
    - Unless these funds are distributed by the county MH Department
  - Prop 36 funds (The Substance Abuse and Crime Prevention Act of 2000).
  - EPSDT funds (Early and Periodic Screening, Diagnosis and Treatment).
  - California Children and Families Commission aka First 5 California funds.

### Add'l Notes:

- If you are unsure whether a site qualifies, ask them. Site training directors and/or supervisors don't always know whether their program receives county MH funding. If necessary, talk with the person there who deals with county contracts (e.g. Finance Officer, Contracts Officer, Comptroller, Executive Director).
- Don't limit yourself to CAPIC, APA or APPIC member sites. Other sites may qualify. Just be aware that if a site is not a CAPIC (or APA or APPIC) member, the procedure for counting Supervised Professional Experience (SPE) hours towards licensure is different.

- Again, there is not a comprehensive list of qualifying sites for this stipend program. However, the CAPIC office has put together a list of sites which, at least at one time, did qualify. A site's inclusion on this list is NOT a definitive indicator that the site is currently receiving qualified funding, only an indication that they have been a qualified site in the past. Again, this list is not comprehensive or definitive, and you must still verify whether the site currently qualifies for MHSA stipend purposes.
