Approved Amendments to CAPIC Membership Criteria *(Effective July 1, 2016)*

ALL CAPIC program members are required to follow the membership criteria for their member type (i.e. Doctoral Academic, Internship and Postdoctoral). The CAPIC board periodically reviews the membership criteria, and when appropriate, proposes changes to them. In keeping with our by-laws and our status as a membership organization in California, such proposed amendments must then be approved by a majority vote of the membership to take effect.

In October of 2015, CAPIC sent out the first announcement of proposed changes to the membership criteria for all three categories of its program members (i.e. Doctoral Academic, Internship and Postdoctoral). These proposed changes were again reviewed by the board prior to sending out the proposed amendments to the membership for a formal vote in June, 2016.

The Membership vote was tallied by the CAPIC Office and certified by the CAPIC board, recognizing a majority vote to approve all of the proposed amendments to the membership criteria for all three categories of its program members. Click [here](#) for a summary of the voting results.

Criteria #2d: Inclusion of "lifespan" psychology as an area of academic training.

Criteria #2d: Modification of "cultural" to "multicultural" competency as an area of academic training.

Criteria #2d: Inclusion of "social justice/diversity" as an area of academic training.

Criteria #2d: Modification of "Psychodiagnostic" to "Diagnostic" assessment as an area of academic training.

Criteria #3: Clarification of dues policy.

Doctoral Internship Program Membership Criteria:

Summary of Amendments:

Criteria #7: Reduction of Full-Time weekly didactic requirements from 4 hours to 2 hours.

Note: Half-Time weekly didactic requirements are unchanged and remain 2 hours/week.

Criteria #7: Removal of redundant language regarding supervision.

Criteria #5: Removal of redundant language regarding supervision addressed elsewhere.

Criteria #8: Deletion of entire criteria by (a) moving requirement for one postdoc fellow to Intro Paragraph and (b) removing requirement that postdoc fellow be on site at time of membership application.

Criteria #14: Removal of stipend hardship exception and related language in Clarifications.
