#### **HISTORY**

CAPIC was founded in 1991 as a consortium of doctoral academic programs and internship agencies, adding postdoctoral members in 2008. It is structured as a non-profit charitable and educational corporation in California.

Founders recognized that doctoral academic programs and internship agencies each offered what the other needed, and that by working together, they could increase the quality of professional psychology training throughout the entire education trajectory, as well as to provide psychological services to the diverse populations in California.

CAPIC doctoral internships and postdoctoral fellowships are recognized by the California Board of Psychology (CA BoP) alongside APA-accredited and APPIC-member programs.

CAPIC training and supervision standards are based on those of the Association of Psychology Postdoctoral and Internship Centers (APPIC).

- Developed and maintains a nationally recognized half-time training model to complement its full-time model.
- Ψ Compiles and maintains online directories of CAPIC internship and postdoctoral training agencies.
- Ψ Provides online training modules on the Resiliency-Recovery treatment approach endorsed by the California Department of Mental Health.
- P Raises public awareness about the social & economic benefits of student services as psychology interns.
- Ψ Works with regional and national associations to advocate for a broader acceptance of therapies of depth, insight and relationship.

# **CAPIC/MHSA Stipend Program**

Since 2008, CAPIC has managed contracts funded through the California Mental Health Services Act (MHSA)/Prop 63 to provide stipends to psychology interns committed to providing publicly funded mental health services.

Under multiple OSHPD/MHSA contracts, CAPIC has distributed \$4.8 million in stipends to 250 students, resulting in over 700,000 hours of public mental health services to Californians.

OSHPD/MHSA is no longer issuing stipends, but has developed an expanded loan repayment program.
